- Election Report: VanHouten stated current registered voters are at 4,370.

 Total voters for March 8, 2016 were 1,579 (36% voter turnout). Precinct # 1 had a 40% turnout, precinct # 2 had a 35% turnout and precinct # 3 had a 34% turnout.
- Proposed Deputy Clerk Position: Starting April 1 the Deputy Clerk would be paid \$3,000 out of the Deputy Clerk account and \$4,000 out of the Deputy Election Official account, totaling \$7,000. This would allow for about 9 hours of work per week. VanHouten noted she would like to reevaluate this and have more hours allotted for the position in order to have the office run more efficiently. Discussion by board.

Motion to eliminate the Deputy Election Official position and just have Deputy Clerk position at \$14,000.00 per year for about 18 hours per week offered by Porter second by Sowerby approved per a roll call vote 7-0
