From the Supervisor:

A portion of Stacey Street east of Lincoln Lake Avenue will have intermittent closure for approximately 3 weeks in November and December starting on Monday, November 7. Stacey Street runs right next to Horseshoe Lake and forms part of the dam/levee that holds up the lake.

Earlier this year, the Kent County Drain Commissioner's engineer observed significant water flow through the road embankment, which is a sign of potential failure of that embankment. Given recent dam failures in the State (Edenville, Boardman Dam, etc), the Drain Commissioner's office and the State's Dam Safety Office determined that repair work should be completed as soon as reasonably possible.

Road closure barricades will be placed at the intersections of Stacey Street and Lincoln Lake Avenue and Morgan Mills Avenue to minimize thru traffic. Complete closure will only be located right near the lake from 8:30 a.m. to 7 p.m. as needed.

From the Assessor:

Please check your tax bill for correct homestead exemption status, spelling, addresses and legal descriptions. If you receive a tax bill and are no longer the owner of the property, please call us, so we can get a tax bill to the new owner.

VETERANS: Please file your VA letter along with the State Tax Commission Affidavit for Disabled Veterans Exemption (form 5107) with the assessor's office prior to the March Board of Review on March 13, 2023 in order to receive your tax exemption for 2023.

Finally, Oakfield Township offers an exemption from property taxes if your household income is below the federal poverty guidelines. If you believe you qualify for an exemption from property taxes for 2023 due to poverty/low income, contact me as soon as possible to begin the application process. You will be required to provide copies of your state and federal income tax returns or Michigan Department of Treasury form 4988 for all members of your household. Please feel free to contact me at the township office on Tuesdays or Wednesdays with any questions regarding the poverty exemption program or any other assessing related matters.
