- Store firewood neatly and away from roadways



Summer taxes are due on July 1, 2025 and are payable until 5:00 p.m. on Monday, September 15, 2025 without fees or penalties.

You can pay in the following ways:

- Check Please write legibly and include the correct date. payable to Oakfield Township, matching written and numerical amounts, and signature.

- Bill pay Payments made through your bank bill pay DO NOT arrive at the township on the date you pay them. Please allow enough time for mailed payments to reach the township before the deadline. **POSTMARKS WILL** NOT BE ACCEPTED AS ON TIME PAYMENTS.
- Cash Please pay with the exact amount. ٠

From the Assessor:



VETERANS: Please file your VA letter along with the State Tax Commission Affidavit for Disabled Veterans Exemption (form 5107) with the assessor's office prior to December 31, 2025. If you believe you qualify for an exemption from property taxes for 2025 due to poverty/low-income, contact me as soon as possible to begin the application process. Even if your household income is higher than the federal poverty guidelines, you may still qualify for a partial exemption. You will be required to provide copies of your state and federal income tax returns or Michigan Department of Treasury form 4988 for all members of your household. Feel free to contact me at the township office on Tuesdays or Wednesdays with any questions regarding the poverty exemption program or any other assessing related matters.

Finally, our reappraisal district for 2025 has started with Hidden Ponds, Holmden Estates, and Lindy Farms and will also include all residential properties on Angel Lake, Deer Lake, Little Blue Lake, and Morgan Lake.

Oakfield Historical Commission

If you've ever noticed the "MUSEUM" signs under the "Podunk Road" signs on Lincoln Lake Road and wondered what they mean, we suggest a little road trip down Podunk Road to find the Oakfield Museum! Due to few volunteers, it's only open on the Fourth Sunday of May through September, but Inside, you will discover a whole world of knowledge about Oakfield Township history!

So, what WAS the big white building before the museum was created? Never a school or church, though it looks like those. Perhaps you recall going there a long time ago to vote? Yes, it was the township hall for many years, but that wasn't its original purpose.

The building was built in 1901 to be the meeting hall of the Oakfield Arbor of the <u>Ancient Order of G</u>leaners. You can see the reproduced <u>AAOG</u> mounted in the peak at the front of the building. The Gleaners were members of the Gleaner Life Insurance Society - a fraternal society that would protect farmers and their families, or others connected with farmers, like millers, veterinarians, etc. They elected local officers and held meetings and other community events.

Many Gleaner artifacts found behind a "secret" door upstairs are on display in the museum. Photos depict the Gleaner officers, both men and women, in their fancy regalia. Members had to be voted on, and if not voted in-- they were "blackballed". Formal rituals and initiations apparently had trials and tests -- ask about the Gleaner goat! In their meeting room upstairs, they also had community dances and events, including the very popular oyster dinners, when oysters were shipped by train from out east for the occasion.

Gleaners still exist today, though not the Oakfield Arbor. In the past, several area Arbors befriended our Oakfield Museum since it had the Gleaner connection, helping with cleaning, donations and such.

Back in 1931 when the township was seeking a new township hall and the Gleaners were having a hard time maintaining the building due to the economy at the time, an agreement was reached with the township purchasing the building for \$1 but allowing the Gleaners to continue to have their meetings upstairs. It remained the township hall until the new hall was built on M-57 in the late 1980s.

In 1989, a small group of township citizens formed the Oakfield Pioneer Heritage Society and received a life lease to create the present Oakfield Museum. The township still owns and maintains the building and now the township's Historical Commission runs the museum inside.

It's open the 4th Sundays of June through September from 2 to 4 pm. Plan a visit to learn so much more—and maybe even get involved yourself! See you at the Museum!!

Fire Department:

As it continues to get warmer, and you head outside to do yardwork, think about the following before lighting a fire: please do not burn on windy days, always be sure to have water close by, and most importantly, always obtain a burn permit before lighting the fire. To obtain a burn permit, do one of the following: call the fire department at 616-754-5122, text the fire chief at 616-318-3405, or click <u>here</u> to fill out the online form. As a reminder, it is not lawful to burn trash, construction lumber, anything containing rubber or plastics, old furniture, tires, etc. Though this is not an exhaustive list, it gives you a basic idea. *Samuel Peterson, Oakfield Township Fire Chief* Who do I talk to if I have a question about...
